

IOWA MASONIC LODGE OF THE YEAR AWARD

- 1.) A copy of this Award application has been mailed to the Worshipful Master, Senior Warden, and Secretary of all Iowa Lodges.
- 2.) Either the Secretary or Worshipful Master (or a member appointed by the Worshipful Master) should be responsible for submitting the report form.
- 3.) Your lodge must have been represented at the 2018 Grand Lodge Session in Des Moines to be eligible for the Award in 2019.
- 4.) Your lodge must score points in each category listed in Group One to qualify for the 2019 Lodge of the Year Award.
- 5.) Lodges must score a minimum of 390 points in Group Two. Points must be earned in 12 of the 15 categories to qualify.
- 6.) Multiple points may be scored only in those categories designated as "per."
- 7.) There is no limit to the number of lodges that can earn the "Lodge of the Year" Award. For instance, if a total of 100 lodges meet the qualifications, then all 100 lodges will receive the "Lodge of the Year" Award at the Grand Lodge Session in 2019.
- 8.) The three lodges with the top point totals will receive special gold, silver, or bronze awards for their efforts.
